## Application to Title and/or Register a Moped

South Carolina Code of Laws Section 56-1-10 (26) defines a moped as a cycle with or without pedals to permit propulsion by human power, that travels on not more than three wheels in contact with the ground whether powered by gasoline, electricity, alternative fuel, or a hybrid combination thereof.

Based on the engine or fuel source, the moped must be:

- ✓ Equipped not to exceed a motor of 50 cubic centimeters, or
- ✓ Designed to have an input exceeding 750 watts and no more than 1500 watts.
- ✓ If an internal combustion engine is used, it must have a power drive system that functions directly or automatically without clutching or shifting by the operator, after the drive system is engaged.

- ✓ Bring and present any documents you have that will show proof of ownership and vehicle specifications (Examples: titles, bill of sale, conditional sales contract, invoices, or out of state registrations)
