



# South Carolina Department of Motor Vehicles Surrender Agreement

DL-49  
(Rev. 01/2020)

To get a South Carolina beginner's permit, driver's license, or identification card all other cards must be surrendered and cancelled. In accordance with SC Code Section 56-1-20, you are not permitted to have more than one SCDMV-issued card except when a secondary driving permit is needed for a different vehicle classification than what is on your primary driver's license. You cannot hold a driver's license or beginner's permit along with an identification card. **The issuance of an identification card will result in all previous driver's licenses being cancelled.**
