- The personalized plates are for cars or light trucks with an empty weight of 9,000 pounds or less and a gross vehicle weight (GVW) of 11,000 pounds or less.
- Depending on your present plate expiration date, an updated tax receipt and additional fees may be required. If your current plate is within three months of expiring, you must pay your property taxes and renew your plate BEFORE you submit an application for a specialty plate.
- The non-refundable fee for a personalized plate is $\$ 30.00$, plus the regular registration fee, and required specialty fee for specialty plates.
